Program Guidelines:

You must complete 32 units comprising:

- 8 units for all MCom Core Courses, and
- 12 units for one Field of Study from MCom Fields of Study, and
- 12 units from MCom Fields of Study (Second Field of Study) OR MCom Elective Options

Students can request to complete a second field of study. Students electing not to complete a second field of study will complete electives for the remainder of their program. Students can complete a maximum of 4 units (2 courses) of electives outside the Master of Commerce (MCom) program course list, subject to prior approval by Business School. These courses must be relevant to your degree and career pathway.

Complete RBUS7999 as an elective in selected postgraduate business programs

Students should have a grade point average (GPA) of at least 4.0 on UQ's 7-point scale, and be in their final year, to be considered for enrolment. Students may be able to count RBUS7999 towards their chosen field of study.
