What is this research about?

This is an early exploration of the current efficacy of mental health care management system and processes in Australia. We are looking into the challenges, gaps, shortcomings and opportunities to improve the quality of the management system from practitioners' perspective. The aim of the study is to make recommendations for the designing of more efficient and robust digital intervention systems to offer better services to Australia.

What will I need to do?

What are the possible risks and disadvantages of taking part?

The nature of the study means that there is limited risk to participants who are involved beyond the risks present in the ordinary activities of daily living and in viewing a computer monitor.

What will happen to the information about me?

All information collected about you will remain confidential. The data collected for this research will be stored electronically and will be protected by passwords. Transcriptions will be de-identified but will be paired to retain the connection of manager and technical staff member to the project. Data will not be shared with other people outside the project and results from the study will not reveal this pairing or any information about them or their organizations. No names, addresses or any other identifying information will be included in any report on the project. The data will be used only for this project. Publications and data collected (de-identified) as a result from this study will be made available in UQ eSpace, UQ's public institutional repository, to allow the dissemination of research. I understand that given the small number of participants, it is not possible to guarantee complete anonymity.

It is anticipated that the results of this research project will be published and/or presented in a variety of forms. In any publication and/or presentation, information will be provided in such a way that you cannot be identified, except with your express permission.
