Professor Brent Ritchie, Academic Dean and Head of School, UQ Business School

Professor Brent Ritchie is Head of School and Academic Dean of Business at UQ Business School. His research focuses on tourism risk management, including organisational responses to crises and tourist risk perception and behaviour. He applies social and organisational psychology to understand risk attitudes and sustainable tourism preferences, particularly in aviation-related carbon offsetting. He has led ARC Discovery and Linkage grants and delivered keynotes at over 12 international conferences.

Professor Ritchie has coordinated research and consultancy projects across Australia, the UK, Vietnam and New Zealand, and has published widely in leading tourism journals. A former editor of the *Journal of Hospitality and Tourism Management*, he serves on 6 editorial boards and is affiliated with research centres in Japan and the USA. He joined UQ in 2008 and previously held academic roles in New Zealand and the UK.



Andrew Petersen, CEO, Business Council for Sustainable Development Australia

Andrew Petersen is the Chief Executive Officer of the Business Council for Sustainable Development Australia (BCSDA), a CEO-led network of over 70 Australian private, public and philanthropic sector organisations advancing the SDGs and climate leadership. Since March 2011, he has directed BCSDA's strategic growth and forged strong global partnerships as the Australian network partner of the World Business Council for Sustainable Development, the We Mean Business Coalition and Business for Nature.

With more than 25 years' expertise in environmental and planning law, Andrew previously held senior legal advisory and policy roles, founding PwC Sustainability & Climate Change practice in 2000. Andrew also serves on the Board of the Australian Packaging Covenant Organisation and on advisory boards at the University of Sydney Business School. His government appointed roles span climate, packaging and biodiversity advisory panels, underscoring his influential role in shaping Australia's sustainable development agenda.

Professor Belinda Wade, Business Sustainability Initiative research hub, UQ Business School

Belinda Wade is an Industry Professor at the UQ Business School with 25 years' experience in sustainability and climate change across the Australian electricity market, higher education and consulting sectors. She works to establish best practices in climate management and understand how companies can align their operations with a carbon constrained future. Major project collaborations include with the Australian Accounting Standards Board examining organisational behaviour in response to mandatory climate reporting; the Future Fuels CRC (hydrogen adoption and biomethane); the Queensland Decarbonisation Hub (sector planning); and, Net Zero Australia (decarbonisation). Belinda has published work in top international journals including *Nature Climate Change*, *Nature Communications* and *Journal of Business Ethics*.

Professor Sara Dolnicar, ARC Australian Laureate Fellow and tourism expert, UQ Business School

Sara Dolnicar is a social scientist and tourism expert at UQ. With degrees in business and psychology, she is best known for her work in improving market segmentation methodology and empirical measures in social science research. She is also an expert in the topic of Airbnb. Currently, Sara is focusing on developing and experimentally testing ways to make consumers behave in more environmentally friendly ways – voluntarily.

Sara has published more than 300 refereed articles. She is the editor-in-chief of *Annals of Tourism Research*, and reviews grant applications for the national funding bodies of more than a dozen countries around the world. She is an elected fellow of numerous professional associations, and the winner of more than 30 research awards.

Kathleen Herbohn is a professor (financial accounting) at the UQ Business School.
