PROGRAM REQUIREMENTS

You must complete 32 units from the [Master of Commerce \(32 units\) list](#), comprising -

- 8 units from Part A; and
- 12 units from one field of study in Part B*; and
- the remaining 12 units as an approved second field of study from Part B or from a combination of other courses in Part B, Part C, Part D and/or other courses approved by the Head of School (up to a maximum of 4 units). Part D courses require permission from the Head of School before enrolment will be approved.

* Students must undertake a field of study in the MCom (32 units). For students who have previously undertaken studies in business or commerce, entry will only be considered for a field of study not already undertaken (some exceptions may apply to Professional Accounting).

Not all courses are offered every semester and/or every year. Check course offerings prior to enrolling.
