You must complete 32 units comprising:

- 16 units from [Master of International Commercial Law](#) component; and
- 16 units from [Master of Commerce](#) component

- 14 units for all MICLaw Core Courses, and
- 2 units from MICLaw Flexible Core Courses

[Master of Commerce](#) component comprising:

- 12 units for one Field of Study from MCom (24 units) Fields of Study, and
- 4 units from MCom Elective Options

Not all courses are offered every semester and/or every year. Check course offerings prior to enrolling.
